Storage	If stored in a cool and dry place and with proper packaging, shelf-life should remain 2 years after production date.
BSE/TSE Declaration	The raw materials used for the salt are not of animal origin. The processing and packing material used during production, repacking or filling the salt, does not make contact with meat products.
GMO Declaration	The product does not contain any genetic modified organisms (GMO) and genetic engineering is not applied during the production process. GMO contamination is excluded during the treatment of the product. Product does not fall within the scope of the EU regulation no. 1829/2003, concerning genetic modified human and animal foods, and the EU regulation no. 1830/2003 concerning the traceability and labelling of genetic modified organisms.
